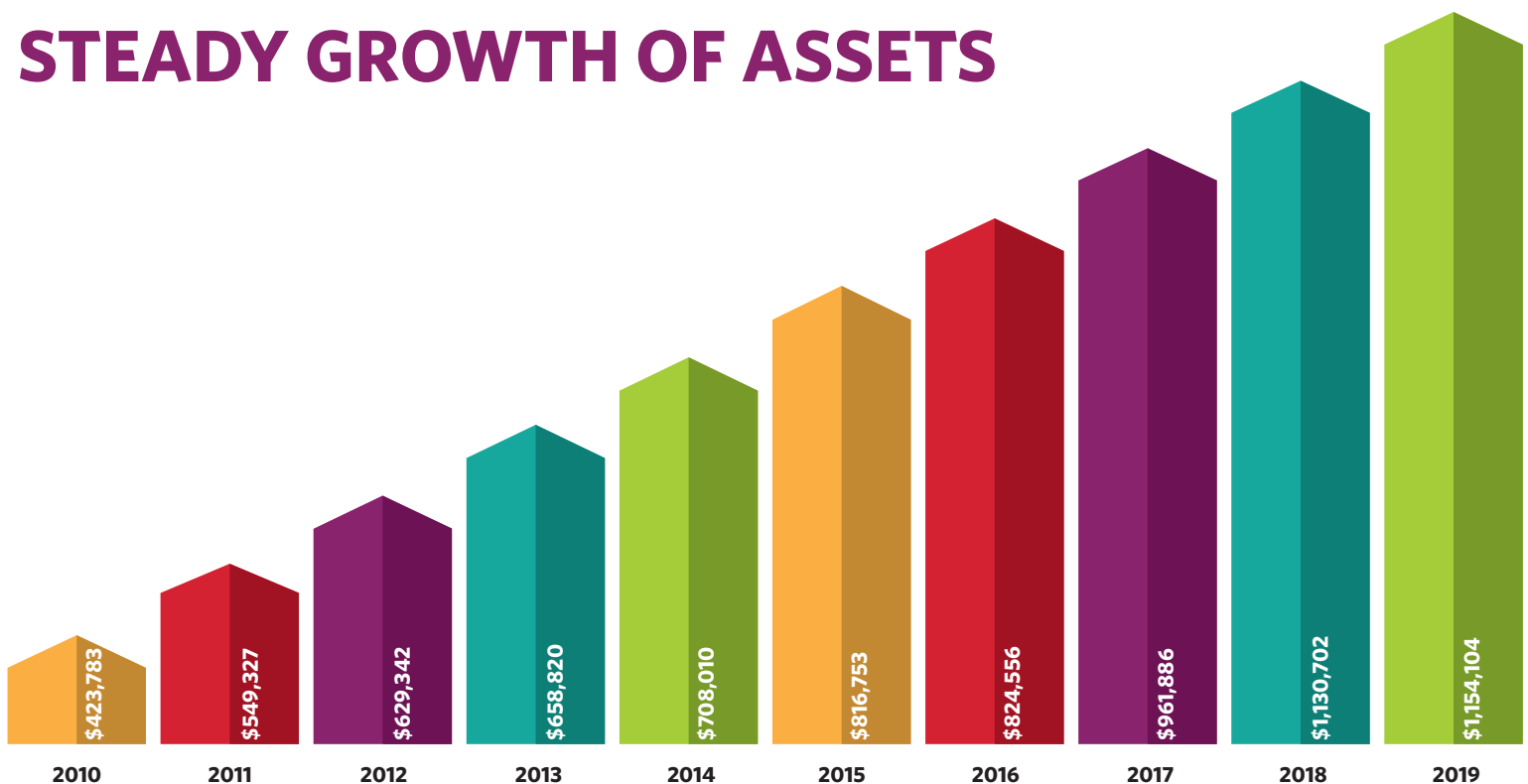
Fiscal year 2019 ended strong, with total contributions of \$465,430. **This is the 10th consecutive year of positive fund growth.**

More than \$255,000 was granted via scholarships, program grants, and project awards. The portfolio return in 2019 was positive 3.10%.
